Secretary from June 2012 due to the previous Secretary resigning due to ill health.

Notts and Derby District Staffordshire Bull Terrier Club – committee member since Feb 2007, Show Secretary during 2008 and have been Secretary/Show Secretary since 2009. Stood down as Show Secretary but still Secretary in 2019.

Secretary of the Terrier Group Judges Development Panel run by the Kennel Club – took up duties Aug 2002 until it finished in 2018.

Treasurer/Membership Secretary of the SBTC from February 2015 until February 2022 when I stood down

Regional Advisor for the Kennel Clubs Assured Breeder Scheme covering a large part of central England since July 2011. A role that I thoroughly enjoy and find very rewarding.

I have judged numerous limit and open shows between 1996 and 2006, and I have awarded CC'S in the UK on 7 occasions to date and have 2 UK SBT breed club Ch Show's to judge later this year.

I have judged extensively abroad in Australia, New Zealand, South Africa, Spain France, Poland, USA, Norway, Czech Republic, from 2009 to date,

I have also judged the Terrier Group at Open Show level on 7 occasions to date.

#### **Rule 131 Regulation**

**Every dog exhibited, or competing at any show, field trial or obedience test  
must be registered with the Irish Kennel Club Ltd, in the name of the exhibitor  
or competitor, save in the case of greyhounds duly registered with the Irish  
Coursing Club and dogs of a non registered breed for which licences have been  
approved for Obedience, Agility or Working Tests.**

**Failure to comply with the above will result in (a) The dog being disqualified  
from the event and (b) The exhibitor being fined, the implementation of which  
shall be a normal office routine.**

**All appeals to the Irish Kennel Club should carry a refundable fee if the appeal  
is upheld.**

# Classification for Breed Club Shows

## DOGS

### **DEFINITION OF CLASSES AT BREED CHAMPIONSHIP SHOW**

(All age classes computed from date of birth.)

**A Puppy Class** is confined to dogs over six and under twelve calendar months of age on the first day of the Show.

**A Junior Class** is for dogs between 9 and 18 calendar months of age on the first day of the Show.

**An Intermediate Class** is for dogs between 15 and 24 calendar months of age on the first day of the Show.

**An Adult Class** is for dogs between 24 and 36 calendar months of age on the first day of the Show.

**An Open Class** is for dogs over 15 months of age on the first day of the Show.

**A Champions Class** is for dogs who have gained the Title of Champion under Irish Kennel Club Rules or under a recognised Kennel Authority **confirmed by the date of closing of entries**.\*

**A Veteran Class** is for dogs over eight years of age on the first day of the Show.

**Please Note: A Veteran Dog who is a Champion may enter in either Veteran or Champion Class but not both.**

**N.B.: A Dog or Bitch may be entered in ONE BREED CLASS ONLY (No double entries)**

**Dogs entered in restricted classes must also be entered in one of the Standard Classes for the breed. All dogs entered must be registered or transferred at the Irish Kennel Club in the name of the Exhibitor.**

### **Neuter Class;**

The classes can be offered at all Championship & Open Shows in the breed and the Best Neuter Male and Best Neuter Female can compete for Best Neuter in Breed and go forward to Best Neuter in Show, **BUT they do not compete for the Green Stars and there is no Neuter Champion title.**

## **ENTRY FEE**

**Service Charge: €25.00 Any number of dogs in the same ownership catalogue included**

## Show Rules

1. **This show** shall be held under the rules of the I.K.C as in force on the day of the schedule. In the following rules the word “dog” will be taken to mean both sexes.
2. **All dogs** must be registered with the I.K.C Ltd and transferred in the name of the exhibitor before the date of the show.
3. **The committee** reserves the right to refuse, on reasonable grounds, any entry they may think fit and also to exclude or refuse any person admission to the show.
4. **The Cork Staffordshire Bull Terrier Society** will not be responsible for any loss or damage sustained by an exhibitor through accident or otherwise.
5. **The Cork Staffordshire Bull Terrier Society** will not be responsible for any accident that may occur to any exhibitor or other person attending this show.
6. **ENTRY FORMS : MISTAKES IN-** The Catalogue will be compiled from the Entry Forms submitted by the Exhibitors, and while every endeavour will be made to have the Forms correctly interpreted, the Cork Staffordshire Bull Terrier Society cannot accept any responsibility for mistakes which may bring Exhibitors within the purview of the Irish Kennel Club Ltd Rule 15, Sect. 1, or clerical mistakes that may occur during the compilation.
7. **Visitors** are requested not to handle the dogs sent or brought for exhibition to this show.
8. **The Cork Staffordshire Bull Terrier Society** will not be responsible for the entire or partial loss or detention of or damage to or injury to or by any dog or dogs or any property belonging to exhibitors or other visitors to this show and it is on this understanding that entries shall be received.
9. **Exhibitor passes** will not be sent, but will be supplied at the show.
10. **As every exhibitor** is deemed to be fully acquainted with the rules and regulations of the I.K.C Ltd. It is advisable to procure a copy of same.
- 11) **Parents** are warned that they are fully responsible for their children’s actions and behaviour at the show.
12. **Judge:** if circumstances arise to prevent the selected Judge from keeping their appointment the committee reserves the right to appoint another judge.
