SHOW REGULATIONS

1. **RULES** The Show will be held under the Rules of the Irish Kennel Club Ltd as in force on the date of the publication of this schedule and will be on display in an abridged form on the day of the Show.
2. **VENUE** The Show will be held at the Munster Agricultural Society Showgrounds on Saturday 18th September 2021
3. **THE ENTRY FEE** will be as follows: **€10.00.** for first dog, includes online catalogue and Car Park subsequent entries €5 per dog class per class (registered to same owner.)

Online entries close at midnight September 5th 2021

The Promoting body will not accept any responsibility for mistakes in the Catalogue which may bring exhibitors within the purview of the Irish Kennel Club Rules.

4. **Catalogues:** Prepaid only Catalogues for collection on show day £2.00. No catalogues for sale on day of the show.
5. **Judging:** Judging will commence in all rings at 11.00 am. Sharp.
6. **Entries:** Online entry at www.dogshowentry.ie Online closes at midnight on the 5th September 2021. Entry Forms: Mistakes in- The Catalogue will be compiled from the Entry Forms submitted by the Exhibitors, and while every endeavour will be made to have the Forms correctly interpreted, Munster Agricultural Canine Society cannot accept any responsibility for mistakes which may bring Exhibitors within the purview of the Irish Kennel Club Ltd Rule 15, Sect. 1, or clerical mistakes that may occur during the compilation.
7. **Rejection of Entries:** The committee reserve the right to reject any entry, advertisement or other insertion in the Catalogue.
8. **Registrations:** All dogs entered for competition at this show must be registered at the Irish Kennel Club Ltd, Unit 36, Greenmount Office Park, Dublin 6. Entries for Greyhounds already registered with the Irish Coursing Club will be accepted without further registration.
9. **Judges:** In the event of the appointed Judge failing to keep his engagement the Committee shall have the right to fill the vacancy thus caused.
10. The Promoting Body will not be responsible for any loss, damage or accident to any person, property or dog in the show or attending same.

IKC & Public Health Guidelines

All exhibitors must abide by all IKC & Public Health Guidelines, in force on the day of the show.

All persons entering the show grounds must complete the supplied Covid-19 track and trace form and returned to the designated area. Failure to do so will result in entry being refused.

Ring numbers will not be sent by post, collect on the day.

As per IKC guidelines, face coverings must be worn at all times on the show grounds.

The show will be held outdoors, tenting areas will be available, strictly in marked out areas.

Exhibitors are requested to leave as soon as is practicable once eliminated from competition

COVID PROTOCOLS ON SHOWDAY

- Exhibitors will not be allowed to setup at the ring side.
- Each ring will have a designated collection area with clearly marked entrance and exit.
- 2m spaces in the collection ring and exhibiting ring
- Each ring will have a designated grooming area.
- With clearly marked entrance and exit.
- Designated Grooming areas will be located sufficiently away from the show rings.
- Grooming and holding areas will be available to breeds 30 minutes prior to judging of their breed.
- Exhibitors must vacate the area on completion of judging of their breed
- Group Competition: It is expected that only Best of Breed winners remain at the venue after breed competition is complete.
- An area for tents/gazebos will be allocated
- There will be no seating available at the show and no crates set up around the ring.
- Exhibitors may bring their own tents/gazebos and seating for use only which must be placed inside their tent/gazebo.
- Tents/Gazebo must only be for their use by their family/travelling pod.
- All tents/gazebos must be 2 metres apart.
- All exhibitors are reminded not to have parties in each other's tents/gazebos and to comply with the social distancing requirements.
- All exhibitors must wear masks or shields.
- Where possible exhibitors should only handle dogs from their own Household, if an additional handler is required, we recommend the exhibitor uses someone from their own travel pod.
- No hairdryers or blasters allowed.
- **All PPE equipment and rubbish must be disposed of correctly to avoid the spread of the virus **
- No overnight parking, camping, caravans or barbeques allowed at the venue
- Exhibitors are reminded to maintain social distance at all times in the car park.
- Please Park where directed by car park attendants.
- Exhibitors must use designated access and exit routes to the show ground
- Non-compliance by attendees will result in them been asked to leave the venue, in the case of an exhibitor been asked to leave their entry will be forfeited
- Only designated photographer/s are allowed take photographs in the ring
