DECLARATION, UNDERTAKING AND AGREEMENT BY OWNER OR AGENT

4. IN CONSIDERATION of my entry being accepted, I hereby agree (1) to indemnify the I.K.C. Ltd. and /or its trustees or officials in respect of any damage or loss from whatsoever source arising, caused by, or to any dogs exhibited by me while in the precincts of the show and (2) that any decision given concerning me by the I.K.C. Ltd. or by any committee thereof in connection with any matter whatsoever arising through or at this show shall be communicated by the secretary of the I.K.C. Ltd. to all whom it may concern , and that any such decision together with a report of the proceedings in the matter may also be published together with my name , address and description.
5. I HEREBY UNDERTAKE to abide by the rules and regulations of the I.K.C. Ltd. and of its' show.
6. I UNDERTAKE to indemnify the promoters against any claims arising out of my participation as a competitor in the show.
