## Show Regulations

1. **The Show** will be held under licence and rules of the Irish Kennel Club Ltd.
2. **Venue:** The show will be held at the Ferryhouse Sports Complex, Waterford Road, Clonmel, Co. Tipperary on Sunday the 17<sup>th</sup> August 2025.
3. **Judging** will commence at 1.00pm.
4. **No claim** will be considered in the event of an exhibit being late for its class. No person will be allowed into the judging ring except the judge, show officials or an exhibitor taking a dog in. For adjudication the exhibit number of each dog must be displayed by its handler.
5. **In the event** of any appointed judge failing to keep his or her appointment the committee reserves the right to appoint another judge or judges.
6. **The committee** reserves the right to alter the proposed order of judging if this should become necessary.
7. **Entry fees:** € 27.00 for first dog irrespective of the number of classes entered. € 10.00 for each subsequent dog.

8. **The committee** reserves the right to reject any entry, advert or other insertion in the catalogue.
9. **Ineligible Entries:** If before judging of a class or classes in which his dog is entered, an exhibitor reports that he has entered a dog in a class for which it is not eligible, he may be permitted to transfer his entry to the equivalent class or classes for the correct breed or sex. No transfer of an ineligible entry is permitted.
10. **Registration:** All dogs entered for competition at this show must be registered or transferred at the Irish Kennel Club Ltd., Unit 36, Greenmount Office Park, Dublin 6.
11. **A judge** will be empowered to withhold any award, prize or Green Star if in his or her opinion the exhibits are not of sufficient merit.
12. **The catalogue** will be available on the day of the show Price € 2.00.
13. **The catalogue** will be compiled from the entry forms and while every effort will be made to have the forms correctly interpreted, the committee can not accept any responsibility for mistakes which may bring exhibitors within the purview of the IKC Ltd., Rule 15, Section 1 or for clerical errors that may occur during compilation.
14. **The promoting body** will not be responsible for any loss or damage sustained through accident by exhibits, exhibitors or other persons attending the show.
15. **The promoting body** shall be the Show Committee and all disputes shall be dealt with by the Show Committee. Parties to any dispute shall have the right to appeal to the IKC Ltd..

8. **Exhibitors** must clean up after their dogs. Suitable facilities will be provided for this purpose. Any exhibitor found not cleaning up after their dog will be liable to a € 30.00 fine.

**Ring numbers will be given out on the day.**

## **IKC RULE 87**

**During the exhibition of dogs the judge may not under any circumstances allow any form of distraction such as distraction by ringsiders and shall disqualify any exhibit which is being assisted in its performance by persons other than the handler.**

### **Important Notice**

#### **Irish Kennel Club Rule Section 1 Rule Registration**

Every dog exhibited or competing at any Show, Field Trial or Obedience Test must be registered with the Irish Kennel Club Ltd., in the name of the exhibitor or competitor, save in the case of greyhounds, duly registered with the Irish Coursing Club, and dogs not of a recognised breed which licenses have been approved for obedience, agility or working tests. Failure to comply with the above will result in (a) the dog being disqualified from the event AND (b) the exhibitor being fined one hundred twenty seven euro (€127), the implementation of which shall be a normal office routine. All appeals to the IKC Ltd. Should carry a fee of € 6.50 refundable if the appeal is upheld.

### Definition of classes at Breed Championship Show

(All age classes computed from the date of birth)

**Baby Puppy Class** is confined to puppies of four months of age and under six months of age on the first day of the show.

Baby Puppies are confined to this class and may not compete for any award

**MINOR PUPPY CLASS:** Is confined to dogs over 6 months and under 9 months of Age on the first day of the Show, computed from and inclusive of its date of its birth.

**A Puppy Class** is confined to dogs over six and under twelve calendar months of age on the first day of the Show computed from and inclusive of the date of its birth.

**A Junior Class** is for dogs between 9 and 18 calendar months of age on the first day of the show, computed from and inclusive of the date of its birth.

**An Intermediate Class** is for dogs between 15 and 24 calendar months of age on the first day of the show, computed from and inclusive of the date of its birth.

**An Adult Class** is for dogs between 24 and 36 calendar months of age on the first day of the Show.

**An Open Class** is for dogs over 15 months of age on the first day of the show, computed from and inclusive of the date of its birth.

**A Champions Class** is for dogs who have gained the Title of Champion under the Irish Kennel Club rules or under a recognised Kennel Authority **confirmed by the date of closing entries.\***

**A Veteran Class** is for dogs over eight years of age on the first day of the show, computed from and inclusive of the date of its birth.

**Please Note: A Veteran Dog who is a Champion may enter in either Veteran or Champion Class but not both.**

**N.B.: A Dog or Bitch may be entered in ONE BREED CLASS ONLY (No double entries)**

**Brace Class** is for two exhibitors of the same or different sexes of the same breed belonging to the same person, each exhibit having been entered in some class other than Brace or Team.

**Neuter Class;** The classes can be offered at all Championship & Open Shows in the breed and the Best Neuter Male and Best Neuter Female can compete for Best Neuter in Breed and go forward to Best Neuter in Show, BUT they do not compete for the Green Stars and there is no Neuter Champion title.

**Dogs entered in restricted classes must also be entered in one of the Standard Classes for the breed. All dogs entered must be registered or transferred at the Irish Kennel Club in the name of the exhibitor**
