In CONSIDERATION of my entry being accepted, I hereby agree (a) to indemnify the IKC Ltd and/or its trustees or officials in respect of any damage or loss from whatsoever source arising, caused by, or to any dogs exhibited by me while in the precincts of the Show and (b) that nay decision given concerning me by the IKC Ltd or by any committee thereof in connection with any matter whatsoever through or at this Show will be communicated by the Secretary of the IKC Ltd to all whom it may concern, and that any decision together with a report of the proceedings in the matter may be published together with my name, address and description.
