- 1. Rules- The Show will be held under the Licence and Rules of the Irish Kennel Club Ltd., as in force on the day of the publication of this schedule.
- 2. All Dogs must be registered with the Irish Kennel Club Ltd. Venue: The Show will be held at Kildangan GAA between the hours of 11.00 and 6 p.m. on Sunday, 2rd March, 2025
- 3. Entry Fees: The Entry Fee will be €10.00 for first dog and €5.00 for each subsequent dog all classes. Postal entry /fees to the Show Secretary, Ms Lynn Kilby, Gaile, Holycross, Thurles, Co Tipperary. Tel: 0504 41165. Postal Entries will be received up to and including 14<sup>th</sup> February 2025. Enter online at www.dogshowentry.ie. Online entry closes at midnight on 21<sup>st</sup> February, 2025. Entry Fees of exhibits failing to arrive or rejected by the Veterinary Surgeon will be forfeited.
- 4. Car Parking Free Catalogues €3.00. Rosettes given in all classes.
- 5. The Show Committee will not accept any responsibility for mistakes in the Catalogue which may bring exhibitors within the purview of the Irish Kennel Club Ltd.
- 6. JUDGES: In the event of any appointed Judge failing to keep his or her appointment, the committee reserves the right to appoint another Judge or Judges. #### CLASS DEFINITIONS

# (The word 'Dog' includes both sexes)

**Baby Puppy Class** is confined to puppies of four months of age and under six months of age on the first day of the show.

Baby Puppies are confined to this class and may not compete for any other award

Puppy Class is confined to dogs over 6 and under 12 months of age on the day of the Show

Junior Class is confined to dogs over 9 and under 18 months of age on the day of the Show.

Intermediate Class is confined to dogs over 15 and under 24 months on the day of the Show.

**An Adult Class** is for dogs between 24 and 36 calendar months of age on the first day of the Show

Open Class is confined to dog over 15 months on the day of the Show.

**Champion Class** is confined to dogs that have attained the title of Champion under the Rules & Regulations of the Irish Kennel Club or other Kennel Authority recognised by the Irish Kennel Club.

**Veteran Class** is confined to dog over 8 years of age on the day of the Show **Neutered Class** 

These classes can be offered at all Championship & Open Shows in the breed and the Best Neuter Male and Best Neuter Female can compete for Best Neuter in Breed and go forward to Best Neuter in Show, **BUT they do not compete for the Green Stars and there is no Neuter Champion title.** 

Please Note: A Veteran Dog who is a Champion may enter in either Veteran or Champion Class but not both.

### N.B.: A Dog or Bitch may be entered in <u>ONE BREED CLASS ONLY</u> (No double entries)

**Brace Class** is for two exhibits of the same or different sexes of the same breed belonging to the same person, each exhibit having been entered in some class other than brace or team.

NOTE: Dogs under the age of six months are not allowed into the show grounds. All dogs entered must be registered or transferred at the Irish Kennel Club in the name of the Exhibitor

#### **Neuter Class**;

The classes can be offered at all Championship & Open Shows in the breed and the Best Neuter Male and Best Neuter Female can compete for Best Neuter in Breed and go forward to Best Neuter in Show, BUT they do not compete for the Green Stars and there is no Neuter Champion title.
