SHOW REGULATIONS

- 1. JURISDICTION:** The show will be held under the Rules of the Irish Kennel Club as in force on the 1st January 2024
- 2. VENUE:** The show will be held at Oylgate Community Centre, Oylgate, Co Wexford
- 3. ENTRY FEE:** Service charge of €10.00 1st Entry and €6.00 for all other entries
- 4. JUDGING:** Judging will commence at 11:30am sharp
- 5. EXHIBITORS:** Each exhibitor shall be responsible for keeping their dogs under control at all times. All dogs must be kept on a lead at all time anywhere in the showgrounds
- 6. FOULING:** Every exhibitor will be required to clean up after their dogs in any part of the showgrounds. Exhibitors are required to bring their own poop scoop or plastic bag for this purpose
- 7. JUDGING RING:** No person will be allowed in the judging ring except the Judge, Show Official or the exhibitor taking in their dog for judging
- 8. ACCIDENT OR DAMAGE:** The Society will not be responsible for any loss or damage by exhibitors or other persons attending the show through accident or otherwise

DEFINITION OF CLASSES

BABY PUPPY CLASS is for dogs from 4 months to 6 months of age on the day of the show computed from and inclusive of its date of birth

PUPPY CLASS is for dogs from 6 months to 12 months of age on the day of the show computed from and inclusive of its date of birth

JUNIOR CLASS is for dogs between 9 months and 18 months of age on the day of the show computed from and inclusive of its date of birth

INTERMEDIATE CLASS is for dogs between 15 months and 24 months of age on the day of the show computed from and inclusive of its date of birth

OPEN CLASS is for dogs over 15 months of age on the day of the show computed from and inclusive of its date of birth

CHAMPION CLASS is for dogs which have gained the Title of Champion under Irish Kennel Club Rules or under a recognised kennel Authority confirmed by the date of entries closing

VETERAN CLASS is for dogs over 8 years of age on the day of the show computed from and inclusive of its date of birth

Best Neuter Male and Best Neuter Female can compete for the Best Neuter in Breed and to forward for Best Neuter in Show, but they cannot compete for Best Male or Female in breed.
